Daylight Beach Club maintains and enforces a strict Zero Tolerance Policy. Appropriate and respectful interactions are required in our Venue. In addition to our proper attire requirements, the company reserves the right to eject or trespass anyone exhibiting behavior, language, or clothing, that at our discretion, is inconsistent with the company's behavior standards.

#### MUST BE 21 & OVER. MANAGEMENT RESERVES ALL RIGHTS.

\*Guests must be 21 years of age and present a valid, current, and undamaged state or country issued driver's license, identification, passport, military ID card, or global entry card is required for ALL guests. **Copies, paper, or photographs of IDs will not be accepted.** *U.S. residents must bring state or federal issued ID; Non-U.S. residents must bring a valid passport or global entry card*.

\*Note: The following items are NOT accepted as valid ID: Mexico Matricula Consular ID (old or current), United States Issued ID stamped "Not for Identification", International Student ID Cards (any type), International Drivers Documents (License), Handwritten Passport, Passport issued when you were a child or teen (cannot verify photo of the person presenting the Passport). The use of forged or fake ID's is illegal and will be subject to the person(s) immediate removal from the premises and possible prosecution.

#### **PROPER ATTIRE REQUIREMENTS**

Guests must comply with all venue dress code requirements. Appropriate dress code is required and strictly enforced. Swimwear is REQUIRED for all day events. The following are NOT permitted:

Sweatpants, jeans, khakis, leggings/tights, etc. No athletic gear of any kind. No chains, steel toe boots, offensive print, torn/cut-off, seethrough bathing suits, or baggy clothing. Under tank tops, under shirts, ribbed tank tops, or similar clothing items will also not be permitted.

## ALL PERSONS, BAGS AND PERSONAL ITEMS ARE SUBJECT TO SEARCH

The following items are **NOT** permitted inside the venue:

- Beach Bags, Beach Purses, Backpacks, drawstring shoe bags, laptop case, camera bag, briefcase, luggage, or any other large bags/purses measuring larger than 8.5" x 11".
- Weapons (any items that may be used to case bodily harm)
- Control Substances
- Illegal Drugs
- Eye Drops/Nasal Sprays
- Marijuana Products (in any form including vapes and edibles)
- Over the Counter and \*Prescription Medications (\*Note Diabetic Kits, Epi Pens, and Inhalers, if medically necessary, are acceptable in original, unexpired, unadulterated container, in the name matching your government issued photo ID, and not requiring refrigeration are acceptable. Such items are subject to inspection by Security Personnel.)
- Gums/Mints/Breath Strips
- Vitamins, Supplements
- Cameras, GoPro, Video Cameras/SLR, DLR, DSLR Cameras/Smart Glasses/Wearable Technology (watches are permitted)/Selfie Sticks
- Colognes/Perfumes
- Chewing Tobacco / Vapes with Refillable Cartidges
- Party Props/Toys/Inflatables
- Eye Drops/Contact Lens Solutions
- Liquid Hand Sanitizer
- Tissues/Wet Naps/Baby Wipes
- Outside Food/Beverages/Food Containers
- Tumblers/Canteen/Water Bottle/Flask

If you wish to deposit any prohibited items into our Amnesty Box prior to entering the Venue, you must ask for a Security Supervisor prior to being searched and/or having your small bag checked. Any prohibited items discovered will be confiscated and disposed by management (without compensation) even if a guest is denied access or remove from the venue.
